On the 25th May 2018 the new European GDPR regulations came into effect and we wanted to take this opportunity to let you know the purpose of our mailing list has not changed and review the membership of the Carers mailing list (Database). **In order to update our mailing list, we are asking you to let us know if you wish to remain on the mailing list by re-registering with us.** The database is growing all the time and therefore it has become necessary to ensure the information we hold is accurate and up-to-date.

The purpose of the Carers Register (mailing list) is:

- To keep Carers up-to-date with relevant information and events
- To provide a profile of carers in the WHSCT and use statistics gathered to evidence future planning and funding bids

How we manage your personal data?

We take protecting your data seriously. We do not share your information with any other departments or external agencies.

What happens if my caring role comes to an end?

If your caring role comes to an end and you no longer wish to receive information you or a member of your family will need to contact us. We are happy to assist former carers with advice and information. However due to the large number of carers currently registered we would encourage former carers to come off the mailing list within a year of their caring role coming to an end. If circumstances change were a former carer takes on a new caring role in the future, they are welcome to come back onto the mailing list.

What do you need to do?
